2. Signs and Markers

The identification signs at the main facility and the pump house were in place containing the required information.

4.a Hydrologic Balance: Diversions

The large rocks in the diversion by the storage pad near the shop area and road diversion leading to the conveyor drop point have been removed. These rocks were identified on the previous inspection.

The culvert inlet by the truck load out has been cleaned.

The straw wattles needing maintenance still need work. Crews are on site completed the list.


The culvert outlet at the top of the road leading to the coal storage pad has not been repaired yet, but crews are on site working.

Work on the diversion going into the sediment pond was being done during the inspection. The diversion has been filled in and is now being armored.


The erosional cut off of the coal storage pile has been filled in.
