### **4.c Hydrologic Balance: Other Sediment Control Measures**


The silt fence around the topsoil pile has been supplemented by wattles. Repairs have been made since prior inspection.

Several thistle plants were observed in the upper storage yard by the topsoil pile and powder and cap magazines. The thistle needs to be treated and removed.






