Business License for West Ridge Resources, Inc. from Carbon County. License #252 issued 01/01/2019, expires 12/31/2019.

2. Signs and Markers

The identification sign at the satellite location of the pump house and the main mine sign were checked as part of the complete inspection. Both signs contained the required information for the operator. The name, address, phone number, and mining permit number. The signs are compliance with the Utah Coal Rules.

3. Topsoil

The thistle identified on the topsoil pile from the prior inspection was taken care of by August 26, 2019, six days after the prior complete inspection of August 20, 2019.

4.a Hydrologic Balance: Diversions

Diversions on site have been cleaned and re-graded and are functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The third quarter 2019 sediment pond inspections were done on 08/20/2019.

4.e Hydrologic Balance: Effluent Limitations

No discharges have occurred.
