2. Signs and Markers

The mine ID signs are located at the contact points of the public road to the permit area and contains all of the appropriate information. All other signs and markers observed during the inspection were in compliance with the approved MRP.

4.c Hydrologic Balance: Other Sediment Control Measures

The snow cover at the site is starting to melt. Several sediment basins that are utilized to drop sediment out prior to the sediment pond have been filled to the point that maintenance will be required in the spring or summer. The operator's representative is aware of the locations and will include them in a routine maintenance of the site this year.

7. Coal Mine Waste, Refuse Piles, Impoundments

Mining of the refuse pile surface continues to take place. The current lift is being excavated on the western half of the refuse pile. The pile appears stable. A diversion has been cut on the southern side of the current lift excavation to drain the pile to the southeastern culvert. The excavated material is being placed into stockpiles to dry and then loaded into trucks to be hauled to the power plant in Sunnyside.
