2. Signs and Markers

The mine ID signs are located at the contact points of the public road to the permit area and contains all of the appropriate information. All other signs and markers observed during the inspection were in compliance with the approved MRP.

4.c Hydrologic Balance: Other Sediment Control Measures

Several sediment basins have material build up in them. These sediment basins are a pre-treatment before the sediment pond. The sediment basins still have water in them from the snow melt. The operator has plans to clean the basins out when they have dried.

7. Coal Mine Waste, Refuse Piles, Impoundments

The culvert on top of the refuse pile used for drainage is in good shape and drainage from the top of the refuse pile is being directed to the culvert inlet. The pile is being mined in lifts. Moisture is visible in the pile surface as it is being mined. The pile appears stable. No visible hazards were present.
