**2. Signs and Markers**

The mine ID signs are located at the contact points of the public road to the permit area and contains all of the appropriate information. All other signs and markers observed during the inspection were in compliance with the approved MRP.

**7. Coal Mine Waste, Refuse Piles, Impoundments**

Mining operations on top of the refuse pile were taking place on the western side due to the weather conditions.

Work needs to be done by the culvert inlet that diverts surface water runoff from the top of the refuse pile. The pile overall is sloped toward the culvert area, however there is a low spot on the west side of the culvert inlet that potentially can store water and not divert it directly to the culvert inlet. Rusty Netz informed the equipment operators that proper drainage from the surface of the refuse pile was of the up most importance and should take a priority over mining of the pile. Operations were initiated to address the problem. The pile appeared stable.

**8. Noncoal Waste**

A few crushed culvert remnants still need to be removed from the side slope of the refuse pile.

**16.a Roads: Construction, Maintenance, Surfacing**

The access road into the refuse pile has been reconstructed by Nelco. There is at least two soft spots in the road that are starting to mushroom. Rusty Netz is going to contact Nelco and address the soft spots in the road before they become a problem in deteriorating the road.

Off tracking of material from the top of the pile in poor weather conditions onto the access road and eventually onto the county road remains a concern that needs to be addressed more then just ways to clean up the material from these roads. Measures need to be investigated and taken to retain the material on site.
