

2. Signs and Markers

The mine ID signs are located at the contact points of the public road to the permit area and contains all of the appropriate information. All other signs and markers observed during the inspection were in compliance with the approved MRP.

4.a Hydrologic Balance: Diversions

The diversion culvert on the top of the refuse pile has been cut and lowered to provide adequate drainage from the surface of the refuse pile.

7. Coal Mine Waste, Refuse Piles, Impoundments

The surface of the refuse pile is being mined from the east to the west and care has been taken to mine the surface with the proper slope to allow drainage from the surface of the refuse pile to the diversion culvert inlet. The pile appeared stable, no visible hazards. No smokers were present indicating proper compaction.
