2. Signs and Markers

The mine ID signs are located at the contact points of the public road to the permit area and contains all of the appropriate information. All other signs and markers observed during the inspection were in compliance with the approved MRP.

4.a Hydrologic Balance: Diversions

The balance of the diversions are still snow covered.

7. Coal Mine Waste, Refuse Piles, Impoundments

The pile was not being mined during the inspection. The drainage from the top of the refuse pile is still positive toward the designed culvert inlet. The pile appeared stable, no visible hazards were observed.
