**2. Signs and Markers**

The mine ID signs are located at the contact points of the public road to the permit area and contains all of the appropriate information. All other signs and markers observed during the inspection were in compliance with the approved MRP.

**4.a Hydrologic Balance: Diversions**

The culvert used to remove any surface flow from on top of the refuse pile has had a 20' section removed to compensate for the pile being mined.

**7. Coal Mine Waste, Refuse Piles, Impoundments**

Refuse pile is being mined in designated lifts. Refuse pile appears stable. No signs of instability.
