**7. Coal Mine Waste, Refuse Piles, Impoundments**

Mining is actively taking place on the surface of the refuse pile. The pile is being mined in lifts. Pile appeared stable and has proper drainage.

Noncoal waste present in pond located behind refuse pile. Trash needs to be collected and disposed of.
