2. Signs and Markers

The mine identification sign is locate along side of the county road at the point of public access to the permit area. The sign contains the required information.

7. Coal Mine Waste, Refuse Piles, Impoundments

The surface or top of the refuse pile is being mined in varied lifts. Proper drainage from the surface of the pile is still directed to the culvert inlet on the south east slope of the pile.
