

2. Signs and Markers

The mine identification signs are located at points of access by the public to the permit area. The signs contain the required information.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile is being actively mined in lifts. The pile appears stable. No visible hazards were observed.

22. Other

A large methane drainage drill pad and hole is being constructed on the land west of the permit area. The pad construction has covered an existing drainage and there is no sediment control structures at the base of the pad construction. The potential exists for a third party interference from drainage off the slope of the pad being directed onto the permit area of SPWF without any treatment.. In addition it appears that some equipment related to this activity has been placed on the SPWF permit area on existing disturbed areas. Notified Rusty Netz of the potential problems.
