

2. Signs and Markers

The mine identification signs were present at both points of public access to the permit area.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds contained runoff from the recent storm events.

4.c Hydrologic Balance: Other Sediment Control Measures

The sediment pre-filter basins were all full of water from the recent storm events. The pre-filter basins are used to collect the majority of the sediment prior to entering the sediment ponds.

7. Coal Mine Waste, Refuse Piles, Impoundments

Haulage of refuse material has been temporarily suspended due to the wet conditions from the recent storm events. Mining is still actively taking place. Pile appeared stable.
