2. Signs and Markers

Mine identification sign is located along side of the county road that is used to access the permit area. The sign contains the required information.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds all contain water from recent storms.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile surface is being mined in lifts. Positive drainage from the surface of the refuse pile is evident. The drainage pattern is directed toward the culvert located on the southeast side of the pile.

11. Contemporaneous Reclamation

A road was cut on top of the eastern refuse pile to drill some sample holes. This portion of the refuse pile is earthen covered. The permittee plans to re-seed this disturbance this fall as determinations have been made not to access this pile in the immediate future.
