Observed the mine identification sign at the entrance into the permit area. The sign contained the required information.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile is being mined actively and being shipped to the co-generation plant located in Sunnyside, Utah. Mining is taking place in the center of the pile surface. The pile appeared stable. No visible hazards were observed. The diversion culvert off the top of the pile is open and functional.
