**2. Signs and Markers**

The mine identification sign is posted along side of the carbon county road used to access the permit area. The sign contains the name, address, phone number, and mining permit number. The sign is in compliance with the coal rules.

**7. Coal Mine Waste, Refuse Piles, Impoundments**

The refuse pile is actively being mined and material is being shipped to the Sunnyside Co-Generation Power Plant locate in Sunnyside, Utah. The pile is stable. No visible hazards were observed during the inspection. The drainage culvert from off the top of the refuse pile is open and functional.
