2. Signs and Markers

The mine identification sign is located along side of the Carbon County road used to access the mining permit area. The sign contained all of the required information set forth in the Utah R645 Coal Rules.

4.a Hydrologic Balance: Diversions

Construction work is currently taking place to remove sections of the culvert that transports runoff from off the top of the refuse pile. This is being done so that future mining off the surface of the refuse pile may occur.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile appeared stable. No visible hazards were observed. Mining of the refuse pile surface is actively occurring. The mining is being done in a manner to provide positive flow to the diversion culvert approved to remove surface drainage.
