

2. Signs and Markers

The mine identification sign was observed on the left side of the county road used to access the mining permit area, looking up-canyon. The sign contains all of the required information.

4.a Hydrologic Balance: Diversions

The diversions through-out the mine site are open and functional.

7. Coal Mine Waste, Refuse Piles, Impoundments

The surface of the refuse pile is being actively mined and placed in piles. The material is then trucked to the Sunnyside co-generation power plant. This material is used as a fuel source.

The refuse pile appeared stable. No visible hazards were observed during the partial inspection.

8. Noncoal Waste

The site is free of noncoal waste items.
