2. Signs and Markers

The mine identification sign is posted along side of the carbon county road used to access the mining permit area. The sign contains the required information set forth in the Utah R645 Coal Rules.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was being actively mined and hauled offsite during the partial inspection. The refuse material is being used as a fuel source for the Sunnyside Co-Generation Power Plant.

The refuse pile appeared stable. No visible hazards were observed during the inspection. Drainage from the top of the refuse pile appears positive toward the culvert that is used to convey water from the surface into a sediment pond.
