2. Signs and Markers

I inspected the identification signs during the inspection. The signs meet the minimum requirements of the R645 coal Rules.

4.a Hydrologic Balance: Diversions

I inspected several diversions and they were open and function as design. Several culverts were inspected and were also open.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

I inspected several sediment ponds and there was no sign of erosion to the in slope or out slopes of the embankments. The sediment ponds were not discharging during the inspection. No water was flowing into the sediment ponds during the inspection. No hazardous conditions were noticed to the sediment ponds.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was active during the inspection. I inspected the refuse pile and did not see any hazardous conditions. The refuse pile appears to be stable.

8. Noncoal Waste

The refuse pile was clear of non-coal waste materials.
