1. Permits, Change, Transfer, Renewal, Sale

There are no permitting actions with the Division at this time.

2. Signs and Markers

The identification signs were inspected and contain the required information as required in the R645 Coal Rules.

3. Topsoil

The topsoil piles were inspected with no signs of wind or water erosion.

4.a Hydrologic Balance: Diversions

I inspected the diversions and culvert throughout the property. They were open and would function as design. No water was flowing within the diversions during the inspection.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds did contain some water due to the recent rainstorms. The permittee had clean out several sediment ponds in the past two months. I did not see any hazardous conditions to these sediment ponds. The embankments appear to be stable.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile is mine for half a day. There are piles of refuse that is ready to be ship on top of the refuse pile. No hazardous conditions were notice during the inspection.

8. Noncoal Waste

The disturb area was clear of non-coal waste materials.

10. Slides and Other Damage

No slides or other damage was noticed during the inspection.

16.b Roads: Drainage Controls

I inspected the road drainage. The diversions and culverts were open. No water was flowing within the structures.
