1. Permits, Change, Transfer, Renewal, Sale

There is no permitting action with the Division.

2. Signs and Markers

The identification signs were inspected and contain the required information as required in the R645 Coal Rules.

3. Topsoil

Topsoil piles are snow covered.

4.a Hydrologic Balance: Diversions

There was snow within some of the diversions. Culverts were open and function as designed. No water was flowing with the diversion during the inspection.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

I inspected the sediment ponds. Most ponds contain water but were not discharging. No hazardous conditions were noticed during the inspection. The embankments appeared to be stable.

5. Explosives

No explosives on site.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was being mined during the inspection. There are piles of refuse stack into pile ready to be loaded into trucks.

8. Noncoal Waste

No hazardous conditions were noticed. The refuse pile appeared to be stable.

10. Slides and Other Damage

No slides or other damage were noticed during the inspection.

16.a Roads: Construction, Maintenance, Surfacing

Roads to the refuse pile were open. No dust control is needed.

16.b Roads: Drainage Controls

Road culverts and diversions were open and functioning as designed. No water was flowing within the diversions and culverts.
