**1. Permits, Change, Transfer, Renewal, Sale**

The identification sign located at the main gate to the refuse pile was inspected. The sign meets the minimum requirements of the R645 Coal Rules. See Photo

**4.a Hydrologic Balance: Diversions**

I inspected several diversions and culverts. They were open and functioning as design. See Photos

**4.b Hydrologic Balance: Sediment Ponds and Impoundments**

Sediment ponds did contain water but were not discharging at the time of the inspection. It is unlikely these structures will discharge in the near future. The embankments appear to be stable. See Photos

**7. Coal Mine Waste, Refuse Piles, Impoundments**

I inspected the refuse pile and I did not see any hazardous conditions. The diversions and culverts would work as designed. Embankments appear to be stable. There are stacks of coal refuse on the top of the pile. This makes it easier to load trucks in the winter.

**8. Noncoal Waste**

The site was clear of non-coal waste material.

**10. Slides and Other Damage**

No slides or other damage was notice during the inspection. The mine site appears to be stable.
