2. Signs and Markers

I inspected the identification sign and it meets the requirements of the R645 Coal Rules at the Plateau refuse pile. See Photo

4.a Hydrologic Balance: Diversions

Diversions and culverts were completely snow covered. Due to low temperatures it is unlikely that the diversions had water flow.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds are snow covered. No sediment pond was discharging during the inspection. It is unlikely that these sediment ponds will discharge in the near future. Embankments, inlets and outlets are snow covered.

8. Noncoal Waste

The property was clear of non-coal waste materials such as oil, trash and grease cans.

16.a Roads: Construction, Maintenance, Surfacing

The main road to the top of refuse pile was open. Road was muddy. There are no dust control problems with the road.
