4.b Hydrologic Balance: Sediment Ponds and Impoundments

Sediment ponds were snow covered. No hazardous conditions were notice. The two sediment ponds inspected were not discharging.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile appeared to be stable. It was snow covered. No hazardous conditions were notice.

8. Noncoal Waste

I did not see any non-coal waste material. I was in the middle of a White Out.

Roads were covered with 4-6 inches of unpacked snow with mud underneath.

Road drainages were snow covered.
