1. There are no pending amendments with the Division at this time.

4.a Hydrologic Balance: Diversions

I inspected the diversions and culverts throughout the property. Some snow was within the diversions and culverts. These structures were function as designed. Some diversions had water flowing within them.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

I inspected a couple of sediment ponds. They contain water but were not discharging and unlikely to discharge. The embankments and inlets were snow covered. No hazardous conditions were noticed. Small amount of water was entering the sediment pond. I did not inspect other ponds due to access roads were snow covered.

7. Coal Mine Waste, Refuse Piles, Impoundments

I inspected the refuse pile and it appears to be stable. I did not notice any hazardous conditions to the snow covered embankments. The refuse pile is inactive due to the snowy conditions. The permittee will be scrapping the snow of the top of the pile.

8. Noncoal Waste

I did not notice any non-coal waste materials. The mine site is completely snow covered.

10. Slides and Other Damage

No slides or other damage was notice during the inspection.
