1. Permits, Change, Transfer, Renewal, Sale

1. There are no amendments under review with the Division.

2. Signs and Markers

The identification sign was inspected and it meets the requirements of the R645 Coal Rules.

4.a Hydrologic Balance: Diversions

I inspected diversions and culverts throughout the property. Diversions and culverts were open and would function during a rainstorm. No water was flowing in the diversions during the inspection.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

I inspected the sediment ponds during the inspection. They were mostly dry and none of the sediment ponds were discharging. No hazardous conditions were noticed. The embankments appear to be stable. The inlets and outlets were open.

7. Coal Mine Waste, Refuse Piles, Impoundments

I inspected the refuse pile and it appears to be stable. I did not notice any hazardous conditions to the embankments. The refuse pile is active. The permittee was mining some to the refuse for fuel for the power plant.

8. Noncoal Waste

The property was clear of non-coal waste materials such as oil, trash and grease cans.

10. Slides and Other Damage

No slides or other damage was noticed during the inspection.

16.a Roads: Construction, Maintenance, Surfacing

The roads were compacted with no dust control problem. The roads were wet and had been recently watered.

16.b Roads: Drainage Controls

I inspected road diversions and culverts. They were open and would function during a rainstorm. See Photos

No new facilities constructed since the last inspection.
