3. Topsoil

The Permittee has received the seed to re-seed the topsoil piles.

4.d Hydrologic Balance: Water Monitoring

The Permittee has received a conditional approval from the Division for the submittal of ground water monitoring data for one year (4 samples); this was reviewed as Task ID # 3420. Final approval is pending, and is based upon submittal of clean copies prepared for incorporation.

15. Cessation of Operations

In order to minimize plant start-up problems (due to the extreme low temperatures), the Permittee is operating around the clock.

16.b Roads: Drainage Controls

Drainage culvert inlets which were visible appeared capable of functioning as designed. Snow removal volumes were not seen in any of the sites diversions.
