4.a Hydrologic Balance: Diversions

All inspected diversions appeared capable of functioning as designed. All observed culvert inlets were clear. No water was observed to be flowing this day.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Both pond incisements were snow covered.

9. Protection of Fish, Wildlife and Related Environmental Issues

The Permittee is required to conduct a burrowing owl survey during the nesting season during the spring of this year. To date, and as far as is known, that survey has not been scheduled.

22. Other

The Permittee submitted a 2009 Annual Report with the required information on February 19, 2010. The Division completed the required review of the submitted information on February 25, 2010. As determined during this review, the Division asked the Permittee to make a minor correction to the surface facilities map, PLATE 5-1. This has been done, but the submittal of the revised Plate to the DOGM is pending.
