**1. Permits, Change, Transfer, Renewal, Sale**

The current State mining permit is undergoing a midterm review.

**3. Topsoil**

The Division suggested on February 23, 2011(during the inspection conducted as part of the mid-term permit review) that the slopes of the topsoil pile located east of the West sediment pond be reduced to a 2H:1V vertical angle, and that the pile be roughened or "pocked". These will be implemented if the germination of the raked in seed (which was planted in November, 2010) is un-successful.

**4.b Hydrologic Balance: Sediment Ponds and Impoundments**

The inlet end of culvert C-7 (inlet culvert into the East sediment pond) as identified on PLATE 7-2 had been cleaned (observed on 2/23). The pond only had a damp bottom. No new compliance issues were identified at the East pond this day.

**16.b Roads: Drainage Controls**

The Permittee has cleared the inlet to the culvert identified as C-1 (18 inch CMP) on PLATE 7-2, Site Watershed and Drainage Map. A concrete "Jersey" barrier has been placed on the road edge above the culvert to prevent haul trucks from getting too close to the edge pushing fill material into the inlet.

**20. Air Quality Permit**

The Permittee had recently made an application of water on the operational haul roads to suppress fugitive dust. Warmer temperatures and lower humidity conditions are now in season.
