1. Permits, Change, Transfer, Renewal, Sale

The Division has issued a conditional approval of the revised information submitted as part of the Midterm Permit Review process, Task ID # 3805. The Division has instructed the Permittee to post an additional \$ 41,000 cash bond, plus submit the required number of clean copies of the revised information to receive final approval of this permitting requirement.

3. Topsoil

A small amount of grass sprouting is evident on the topsoil pile located east of the west sediment pond. The area has only had a few warm days to assist with the germination of the seed on these piles.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Both of the sites sediment containments were inspected; both ponds have a small volume of water. The inlets and the open channel spillways were capable of functioning as designed. Minor rilling is evident on the inslopes. No hazardous conditions or compliance issues were identified.

9. Protection of Fish, Wildlife and Related Environmental Issues

No wildlife was seen during today's inspection.

20. Air Quality Permit

The operational roads at the site had been watered prior to the onset of today's inspection.

21. Bonding and Insurance

As noted elsewhere, the Permittee has been told to increase the amount of reclamation bond posted to reclaim the site by \$ 41,000. The new amount posted will ensure the reclamation of the site through 2016.
