1. Permits, Change, Transfer, Renewal, Sale

The Division and the Permittee completed the mid-term permit review process (Task ID # 3805) on May 26, 2011 with the submittal of four clean copies prepared for incorporation into the MRP and the posting of an additional \$ 41,000 of cash surety. The re-calculation of the reclamation cost estimate is \$ 206,000, which is the amount of cash surety now posted.

4.a Hydrologic Balance: Diversions

All observed diversions at the site appeared capable of functioning as designed. The inlet ditch to the West Pond was carrying water; all others were dry.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Both ponds at the site contained some water. Neither pond was close to discharging. No compliance issues were identified.

13. Revegetation

New growth is appearing on the slopes and in the water retention areas of the topsoil pile located east of the West Pond. Most of the growth appears to be grass.

20. Air Quality Permit

Applications of water had recently been made to the areas where machinery was being operated.
