3. Topsoil

Mr. Edwards indicated that the Permittee plans to replace the silt fence around the topsoil pile located east of the West pond. The Division recommended that the Permittee consider a permit change which would replace the silt fence with a designed berm. Mr. Edwards plans to discuss that possibility with the Environmental Manager.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The Permittee has initiated the cleaning of the East pond; the cleanout material is stored on the pad immediately adjacent to the pond. Mr. Edwards indicated that the annual impoundment inspection requirements with P.E. certification had been completed. The West Pond contained ice.

No wildlife was observed during today's inspection.
