1. Permits, Change, Transfer, Renewal, Sale

The Division granted final approval of Task ID # 4089, Topsoil Stockpile, on June 6, 2012.

3. Topsoil

The Permittee has initiated construction of the runoff retention berm about the main soil storage pile located east of the west pond , (See comment under Item 1).

15. Cessation of Operations

The site is receiving 2000-4000 tons per day of feed stock from the West Ridge Mine.

20. Air Quality Permit

The sites roads were dry; the water truck is being repaired. Mr. Edwards indicated that the truck would be back in service today.

22. Other

As noted elsewhere, the site is being accessed by 50 to 100 trucks per day. It is imperative that roadway watering be resumed ASAP.
