1. Permits, Change, Transfer, Renewal, Sale

The Division has a mid-term report for Wellington Dry Coal and is schedule to be completed by February 14, 2017.

2. Signs and Markers

I took a picture of the Wellington dry coal identification sign (see picture). It complies with the requirements of the R645 Coal Rules. All necessary required information is on the sign.

3. Topsoil

Topsoil piles were covered in snow. There were no signs of erosion of any kind.

4.a Hydrologic Balance: Diversions

Diversions were covered with snow. I did not see any water flowing within the diversions. No water was entering the sediment ponds.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Sediment ponds were snow covered. No hazardous conditions were noticed. The ponds were not discharging at the time of the inspection.

8. Noncoal Waste

The site was snow covered and did not see any non-coal waste materials.

16.a Roads: Construction, Maintenance, Surfacing

Roads were snow covered. No dust problems.

16.b Roads: Drainage Controls

Road drainages were snow covered. No water was flowing or melting of snow on the roads.

18. Support Facilities, Utility Installations

No new facilities since the last inspection.
