1. Permits, Change, Transfer, Renewal, Sale

2. Signs and Markers

The identification sign was inspected and it meets the requirements of the R645 Coal Rules. See Photo

3. Topsoil

I inspected the topsoil piles and I did not see any signs of wind or water erosion. The topsoil piles appear to be stable and protected by a berm. See Photo

4.a Hydrologic Balance: Diversions

The diversions and culverts were open and functioning as designed. Sediment has started to fill within these structures. By next spring, a major cleaning of ditches and diversions will be needed. Some diversions were recently cleaned.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

I inspected the sediment ponds throughout the property. They contained some water but were not discharging. It is unlikely these structures will discharge in the near future. The embankments appear to be stable. Inlets and outlets would function as designed. I did not see any hazardous conditions to these structures. The permittee conducted a fourth quarter sediment pond inspection on October 16, 2017. No hazardous conditions were reported. See Photos

4.d Hydrologic Balance: Water Monitoring

Water monitoring information is taken by the permittee and is sent electronically to the Division in Salt Lake City. This information is reviewed and analyzed by the Division staff. A report is written.

4.e Hydrologic Balance: Effluent Limitations

There was not discharge from the sediment ponds for the fourth quarter.

8. Noncoal Waste

The property was clear of non-coal waste materials such as oil, trash and grease cans.

10. Slides and Other Damage

No slides or other damage was noticed during the inspection.

16.a Roads: Construction, Maintenance, Surfacing

The roads were compacted with no dust control problem.

16.b Roads: Drainage Controls

I inspected the road diversions and culverts throughout the property. They were functioning as designed. See Photos

No new facilities constructed since the last inspection.

21. Bonding and Insurance

I conducted complete inspection at the Wellington Dry Coal Facility. As part of the requirements, of a complete inspection is to examine the "Certificate of Liability Insurance". This insurance policy had expired on February 5, 2018. No, renew liability insurance certificate was given to me. I gave the permittee until 4 pm on February 8, 2018 to submit a renewal insurance certificate to the Division. This was slightly over 24 hours from the time of the inspection. No policy was received and a Cessation Order was issued, closing the operations until a renewed "Certificate of Liability Insurance" is received by the Division. The abatement is to receive valid liability insurance certificate within 30 days.
