1. Permits, Change, Transfer, Renewal, Sale

Diversions that could be seen appear to be stable and functioning as designed.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

I did not see any hazardous conditions to the sediment ponds. The sediment pond outcrops appear to be stable. These are incised sediment ponds.
