1. Permits, Change, Transfer, Renewal, Sale

There is one permitting action with Wellington Dry Coal. It is to respond to the Division Midterm Completeness. The permittee was to respond by March 30th.

2. Signs and Markers

The identification sign was inspected and it meets the requirements of the R645 Coal Rules. See Photo

3. Topsoil

I inspected the topsoil piles and I did not see any signs of wind or water erosion. The topsoil piles appear to be stable and protected by a berm.

4.a Hydrologic Balance: Diversions

It was difficult to see diversions through the fence and having wrong angles to examination. It appears diversions were functioning as designed. Most likely sediment cleaning in some diversions is needed.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

I did not see any hazardous conditions to the sediment ponds. These ponds are incised. No leaking of water was noticed from the embankments. Most likely the sediment ponds had a small amount of water. It is highly unlikely these ponds are discharging or have discharged. These ponds have never discharged in the past.

8. Noncoal Waste

The property was clear of non-coal waste materials such as oil, trash and grease cans.

15. Cessation of Operations

A Cessation Order #21020 was written for not having Liability Insurance. The site was ordered to shutdown until insurance is purchased for Wellington Dry Coal.
