1. Permits, Change, Transfer, Renewal, Sale

There are no permitting actions with the Division at this time.

2. Signs and Markers

The identification sign was inspected and it meets the requirements of the R645 Coal Rules. See Photo

3. Topsoil

I inspected the topsoil piles from the fence line, and, I did not see any signs of wind or water erosion. The topsoil piles appear to be stable and protected by a berm.

4.a Hydrologic Balance: Diversions

The diversions most likely are functioning but most likely need maintenance. It is highly likely sediment has been deposited within the diversions.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

I could not see within the sediment pond because they are incised. Since, there has been little rainfall it is likely these ponds are dry.

8. Noncoal Waste

The property was clear of non-coal waste materials such as oil, trash and grease cans.

15. Cessation of Operations

The facility was not operating. The gates were closed. This is a company decision. The Division has given permission to the company to conduct business.

16.a Roads: Construction, Maintenance, Surfacing

Roads were dry. No dust was coming off from the roads. There was little to no wind during the inspection.
