1. Permits, Change, Transfer, Renewal, Sale

No records can be seen since the office and main gate are closed. No people are on the property. I could not conduct a complete inspection since first quarter of 2018. It is rumored that all mobile equipment was taken by the county for behind taxes.

2. Signs and Markers

The identification sign was inspected and it meets the requirements of the R645 Coal Rules. See Photo

3. Topsoil

The topsoil pile appears to be stable from viewing at a distance.

4.a Hydrologic Balance: Diversions

Diversions were in poor conditions on the last inspection when the gate was open. I am guessing condition has not change for the better.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds are incised. I could not see anything but the outslopes of these structures. They appear to be stable. No quarterly inspections have been conducted by the permittee to my knowledge since the first quarter of 2018.

4.e Hydrologic Balance: Effluent Limitations

Can not inspect.

8. Noncoal Waste

There is a small amount of non-coal waste.

10. Slides and Other Damage

No slides or other damage was notice from outside fence line.

21. Bonding and Insurance

I was unable to inspect. No one on the property.
