1. Permits, Change, Transfer, Renewal, Sale

The Division considers Wellington Dry Coal as an abandon site.

2. Signs and Markers

The identification sign is no longer accurate since this Wellington Dry Coal is now considered abandon. The Division has tried several times to contact the permittee with the address on the sign with no response.

3. Topsoil

I inspected the topsoil piles and I did not see any signs of wind or water erosion. The topsoil piles appear to be stable and protected by a berm.

4.a Hydrologic Balance: Diversions

A violation had been written last August 2018 for diversions and culverts were filled with sediment. No action was taken to correct the violation.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Ponds are still functioning but no quarterly inspections are taken by the permittee.

7. Coal Mine Waste, Refuse Piles, Impoundments

It is my opinion that there is 40,000 to 60,000 tons of refuse material on site. All coal with any value was taken by Bowie Resources Partners LLC, during August 2018.

8. Noncoal Waste

The site has some non-coal waste material needing to be pick up.
