4.a Hydrologic Balance: Diversions

The diversion ditches were in violation last year and a Notice of Violation was written. No action was taken to repair or clean out these diversions and culverts.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Most likely the sediment ponds are dry. I could not see the bottom of the sediment ponds from the fence line. See Photo

7. Coal Mine Waste, Refuse Piles, Impoundments

There are refuse material throughout the property. See Photos

8. Noncoal Waste

There is a small of non coal waste material inside the fence line.

16.a Roads: Construction, Maintenance, Surfacing

Roads are well compacted.

16.b Roads: Drainage Controls

Diversions were in poor conditons. When I was able to inspect them.
