**1. Permits, Change, Transfer, Renewal, Sale**

The current permittee, Carbon Resources has an approved mining and reclamation plan, but has not posted a bond to date. Once the bond is posted the permit transfer process can begin.

**3. Topsoil**

The equipment used for exploration has been removed from the approved surface facilities area, the permittee plans to scarify and seed the area this fall and install a fence and gate to protect the area. Representatives from Carbon Resources presented this proposal at the DOGM offices in Salt Lake on August 16, 2012 in order to protect the area in the interim until mining activities begin.

**9. Protection of Fish, Wildlife and Related Environmental Issues**

Dan Richards, Jerry Jones, Makeda Hansen, Nicole Nielson and Joe Helfrich met at the Scofield State Park and picked two locations for osprey nesting platforms, one at the north end of the reservoir on State Parks property and the other at the camping facility near the dam on BOR property which seemend to be the preferred choice with the group. That being the case Dan would need to forward the platform plans to the BOR for approval. The goal is to have the platform installed before the ground freezes in October. DOGM has requested Carbon Resources to follow up on the installation of the Purple Martin nesting boxes by private citizens in Scofield.
