1. PERMITS, CHANGE, TRANSFER,

The reclamation only permit was renewed August 13, 1995 and will expire August 13, 2000. The bond amount specified in the permit is \$126,078.

2. SIGNS AND MARKERS

Signs and markers were in place. The permit entry sign was visible upon entry to the site.

4. HYDROLOGIC BALANCE

- a. Diversions - No flows were noted in any of the Diversions.
- b. Sediment Ponds and Impoundments - The sediment pond was dry.
- c. Other Sediment Control Measures - The silt fence on top of the refuse pile at the east boundary was in good repair.

13. REVEGETATION

The site was very dry no noticeable difference was observed from the previous inspections.
