### 1. PERMITS, CHANGE, TRANSFER,

The reclamation only permit was renewed August 13, 1995 and will expire August 13, 2000. The bond amount specified in the permit is \$126,078.

### 2. SIGNS AND MARKERS

Signs and markers were in place. The permit entry sign was visible upon entry to the site.

### 4. HYDROLOGIC BALANCE

a. Diversions - No flows were noted in any of the Diversions.

b. Sediment Ponds and Impoundments - The sediment pond was dry. Jim Blackburn, operators representative, inspected the pond November 2, 1995 and certified no obvious problems with the pond.

### 13. REVEGETATION

The site was very dry no noticeable difference was observed from the previous inspections. No spring greening of vegetation had occurred. Soil moisture was very dry.

### 21. BONDING & INSURANCE

Liability insurance is carried by Sphere Drake Insurance and expires 4/1/96. E. M. Gerrick was left a message on 3/28/96 reminding him of the expiration date of the insurance policy.

The bond in the amount of \$126,078 is held by Seaboard Surety Company.
