Attached please find our schedule for ACR's for federal lands plans in Utah. Also identified is the Technical Project Officer(s) for the groups of plans.

With respect to a "minor" action on Belina #2, we await your decision as to whether to proceed as we suggested (request a detailed mine map showing the needs for about one year; probably heavily stipulate sediment control compliance). With respect to U.S. Fuel's conveyor, we are working on a draft analysis of what we could undertake to provide limited approval and will get that to you for review. I would venture a guess that the needs for undertaking a minor action are beginning to be satisfied for the conveyor. The status of the existing road needs to be cleared up as we discussed.

We are pushing hard for a succinct analysis of the significance of the alluvial valley floor at Sage Point Dugout and will get a draft to you as soon as possible.

We are also proceeding to obtain USGS recommendations for Plateau's extension.
