1.) Permits - The operator's permits are current and in effect. N.O.V.'s 91-26-8-2; 2 of 2, and 91-26-8-2; 1 of 2 remain unabated and are still being decided by the courts.

2.) Signs and markers - The Stream buffer signs needed to be painted and the operator had paint with him to carry out that task.

4a.) The main stream channel diversion is in good repair and has not seen any significant events this year.

4c.) Sediment Control Measures - All silt fences were operational and in good repair. It appeared as if some maintenance had occurred on the road to areas around several of the water bars.

4d.) Water Monitoring - The operator's consultant Karla Knopp was taken water samples the day of the inspection on Ivie Creek.

9.) Wildlife - Elk usage which had occurred on site was evident throughout the entire site in the form of harden hoof prints.

13.) Revegetation - No revegetation has been carried out since the last inspection. Many areas of the site still exhibit a robust annual weed crop.

14.) Bonding and Insurance remain current and in effect until 7/01/93.
