4.c Hydrologic Balance: Other Sediment Control Measures

The diversions and waterbars were in good repair and functioning properly at the time of this inspection.

4.d Hydrologic Balance: Water Monitoring

Ivie creek was flowing at approximately 3GPM from recent storms. Previous flash flooding had raised the flow along the banks approximately 3'.

16.b Roads: Drainage Controls

Water bars along the access road were in good repair.
