1. Permits, Change, Transfer, Renewal, Sale

The reclamation permit was renewed on January 29, 2002 and expires January 30, 2007.

2. Signs and Markers

A sign containing the required information was posted at the entrance to the access road.

4.c Hydrologic Balance: Other Sediment Control Measures

Silt fences are the primary sediment control along with water bars and pocking on portions of the reclaimed area.

13. Revegetation

The vegetation on the reclaimed area and road is doing well. However, the Russian Thistle is becoming more prevelant along the old access road, which is fairly common for this time of year.
