A sign containing the required information was posted at the entrance to the access road.

4.c Hydrologic Balance: Other Sediment Control Measures

Additional silt fencing has been added to the silt fence located at the toe of the reclaimed slope. Additional hand work may be necessary to ensure adequate sediment retention. The fence will be inspected again in November.

4.e Hydrologic Balance: Effluent Limitations

Water was flowing in Ivie Creek at approximately one cfs. Recent storms have resulted in temporary increased flows in Ivie creek. These flows are evidenced by the higher water marks along the banks of the stream.
